

WAIVER AND RELEASE OF LIABILITY

In consideration of Rathbeggan Airsoft Ltd (hereinafter referred to as "RAS") agreeing to furnishing services and /or equipment to enable me to participate in Combat Simulations and/or Airsoft games, I agree and acknowledge as follows:

1. I fully understand and acknowledge that;

(a) risks and dangers exist in my use of Airsoft equipment and my participation in Combat Simulation/Airsoft activities;

(b) my participation in such activities and/or use of such equipment may result in my injury or illness including but not limited to bodily injury, disease strains, fractures, partial and/or total paralysis, eye injury, blindness, heat stroke, heart attack, or other ailments that could cause serious disability or death;

(c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of RAS; the negligence of the other participants, the negligence of third parties not employed by or agents for RAS, or by accidents, breaches of contract, the forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes; and

(d) by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, employees of RAS, or by any unconnected third party.

I, on behalf of myself, my personal representatives and my heirs, hereby agree to release, waive, discharge, hold harmless, defend and indemnify RAS and its owners, agents, officers and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of Airsoft equipment or my participation in Combat Simulation/Airsoft activities. I specifically understand that

(1) I am releasing and discharging RAS from and do waive any claim which but for this waiver I might have had in respect of actions that I might have whether at this time or in the future for the negligent acts or other conduct by the owners, agents, officers or employees of RAS.

(2) I release RAS and all or any other Occupiers for the time being from any claims that might otherwise subsist under the Occupiers Liability Act, 1995, save only in respect of such claims as are by virtue of paragraph (c) of section 8 of the said Act not susceptible of waiver.

MEDICAL PERMISSION AUTHORIZATION

In respect of the participants, if any, whose names are set out below and being person[s] below the age of majority, the undersigned parent or guardian hereby gives permission for RAS to authorize emergency first aid or medical treatment as may be deemed necessary by RAS for the minor[s] named below while participating in Combat Simulations and/or Airsoft games at RAS.

I HAVE READ THE ACKNOWLEDGEMENTS AND WAIVERS AND THE ABOVE MEDICAL PERMISSION AUTHORISATION AND BY SIGNING IT I AGREE TO EXEMPT AND RELIEVE RAS FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE.
